## 1. HOW TO ENTER

- a. These rules govern the “Vacation to Aulani, A Disney Resort & Spa – Winter/Spring 2021” promotion (the “Promotion”), which is being conducted by KOIT-FM, KUFX-FM, KMVQ-FM (the “Station”). The Promotion begins on March 22, 2021 and ends on April 16, 2021 (the “Promotion Dates”).
  - i. To enter the Promotion, entrant may enter online beginning on March 22, 2021 at 12:01am Pacific Time (“PT”) and ending on April 11, 2021 at 11:59pm PT (the “Entry Period”) as follows:

Entries are subject to all notices posted online including but not limited to the Station’s Terms of Use and Privacy Policy. Only one (1) Vacation to Aulani, A Disney Resort & Spa – Winter 2021 Entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.
  - iii. To enter the Promotion, entrant may enter on-air beginning on April 12, 2021 at 6:00am Pacific Time (“PT”) and ending on April 16, 2021 at 4:59pm PT (the “Entry Period”) as follows:

- iv. To enter on-air, listen to KOIT-FM during the entry period beginning on April 12, 2021 at 6:00am PT and ending on April 16, 2021 at 4:59pm PT for the Secret Song of the Day to be played in accordance to the e-mail blast/newsletter sent by the station. Upon hearing the Secret Song of the Day, the designated caller (as specified in the email blast/newsletter sent from the station) to get through to the Station contest line at 415-777-5648 will be awarded the prize and will be qualified for the grand prize, upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a qualifying prize winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a qualifying prize winner only once.

Registered email club members will receive the Secret Songs of the Day that they need to listen for, the day(s) and time(s) the songs will play. When the Secret Song of the Day plays, caller 25 into the studio at 415-777-5648 will win a qualifying prize of four (4) \$25.00 Disney Gift Cards. The card(s) are valid at Disney Stores across the U.S. online at DisneyStore.com, as well as select locations at Walt Disney World® Resort, Disneyland® Resort and Disney Cruise Line®. Gift cards cannot be used to purchase a Subscription. The approximate retail value of the prize(s) is \$100.00. Entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.

  - a. There will be up One (1) grand prize winner selected at the conclusion of the Promotion.
  - b. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts

and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

- c. Only one (1) entry or qualifying prize per person is permitted.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in one of nine (9) county jurisdiction that makes up the Greater San Francisco / Bay Area listening area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

## 3. PRIZES

- a. Five (5) on-air qualifying prizes will be awarded. Each qualifying prize includes four (4) \$25.00 Disney Gift Cards. The card(s) are valid at Disney Stores across the U.S. online at DisneyStore.com, as well as select locations at Walt Disney World® Resort, Disneyland® Resort and Disney Cruise Line®. Gift cards cannot be used to purchase a Subscription. The Retail Value (“ARV”) of each qualifying prize is \$100.00. Some restrictions apply. The gift card(s) will be subject to the terms and conditions as set forth by the issuer of the gift cards. Gift cards are not refundable or transferable and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen.
- b. One (1) grand prize will be awarded. The grand prize is a vacation for four (4) persons (for the grand prize winner and three (3) guests) to Aulani, A Disney Resort and Spa and in Ko Olina Hawaii (the “Resort”). The grand prize includes the following: (i) four (4) round-trip coach airfares between a San Francisco area airport closest to the winner’s residence as chosen by Disney and the Honolulu International Airport (at Disney’s selection with possible layovers); (ii) a voucher for ground transportation between the Honolulu International Airport and the Resort for the grand prize winner and three (3) guests); (iii) one (1) standard room (maximum of four (4) persons per room) at the Resort for four (4) nights; and (iv) \$200 Resort spending credit valid at the Resort. The ARV of the grand prize is \$5,249.00, but may vary depending on travel origination and fares in effect at the time of departure. Certain restrictions (including COVID restrictions) shall apply to the vacation packages, which restrictions shall be determined by Disney in its sole and absolute discretion. The vacation packages (and all elements thereof) are not redeemable for cash and are non-transferable except in Disney’s sole and absolute discretion. The Vacation Package must be booked through a travel agent as designated by Disney at least forty-five (45) days prior to arrival. Block-out dates apply. No extensions will be granted. Certain travel and logging restrictions apply including airline carrier’s regulations and conditions. Airline tickets are non-refundable, non-transferable and are not valid for upgrades. - f. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). Entrants acknowledge that the Promotion Entities have not made and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability,

mechanical condition or fitness for a particular purpose. Other restrictions may apply.

- g. Winner will be required to provide his/her social security number and any other documentation and/or sign any documentation Station requires as determined in its sole discretion as a condition of accepting the Prize.
- h. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets that have been awarded in the event of show cancellations as a result of weather, promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.
- i. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. One (1) grand prize winner will be selected on or around Monday, April 19, 2020 at around 12:00pm, from the qualifying on-air and online entries received at [www.KOIT.com](http://www.KOIT.com), [www.KFOX.com](http://www.KFOX.com) and [www.997now.com](http://www.997now.com) as described above in Section 1 of these Official Rules.
- c. Odds of winning a qualifying prize depend upon the number and order of eligible entries received.
- d. Winners do not need to listen to the Station to win and do not need to be present to win. All prizes must be claimed within thirty (30) days of winning, as directed by the Station. Public health conditions do not permit a Winner to claim the prize in person, so the Station will coordinate with the Winner to confirm his or her identity remotely and deliver the prize by mail or other means of delivery. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that entrant from

If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s).
