**1. HOW TO ENTER**

- a. These rules govern the “KUFX-FM Tickets to the *Disneyland*® Resort Giveaway – Halloween Time 2023” promotion (the “Promotion”), which is being conducted by KBLX-FM (the “Station”). The Promotion begins on Monday, August 14, 2023, and ends on Friday, September 1, 2023 (the “Promotion Dates”).
- b. To enter the Promotion, entrant may enter online beginning on Monday, August 14, 2023, at 12:00am Pacific Time (“PT”) and ending on Friday, September 1, 2023, at 11:59pm (PT) (the “Entry Period”) as follows:
  - i. To enter online, visit [www.KFOX.com](http://www.KFOX.com) and follow the links and instructions to enter the Contest and complete and submit the online entry form (“Tickets to the *Disneyland*® Resort Giveaway – Halloween Time 2023 Entry”) during the Entry Period outlined above. Entries are subject to all notices posted online including but not limited to the Station’s Terms of Use and Privacy Policy. Entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

- ii. Only one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. Entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.

Void where prohibited or restricted by law.
- b. #### 4. WINNER SELECTION AND NOTIFICATION

- b. Twenty (20) on-air prize winners and one (1) online prize winner from the qualifying on-air and online entries received at [www.KFOX.com](http://www.KFOX.com) at the conclusion of the Promotion will be selected as described above in Section 1 of these Official Rules.
- c. Odds of winning a prize depend upon the number and order of eligible entries received.
- d. Winners do need to listen to the Station to win and do not need to be present to win. All prizes must be claimed within thirty (30) days of winning, as directed by the Station.
