## 1. HOW TO ENTER

- a. These rules govern the “KUFX-FM Golf Experience at Cache Creek Casino Resort Online Giveaway” promotion (the “Promotion”), which is being conducted by KUFX-FM (the “Station”). The Promotion begins on Wednesday, September 25, 2024, and ends on Wednesday, October 23, 2024 (the “Promotion Dates”).
- b. To enter the Promotion, entrant may enter online beginning on Wednesday, September 25, 2024, at 12:00 am Pacific Time (“PT”) and ending on Wednesday, October 23, 2024, at 11:59pm (PT) (the “Entry Period”) as follows:
  - i. To enter online, visit [www.KFOX.com](http://www.KFOX.com), Wednesday, September 25, 2024, at 12:00 am Pacific Time (“PT”) thru Wednesday, October 23, 2024, at 11:59pm (PT) and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. At the time of entrant’s submission, the entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and

evening phone numbers, and date of birth to be eligible to win. P.O. Boxes are not permitted. A listener may be a prize winner only once.

- ii. Only one (1) entry per eligible person during the Entry Period regardless if the entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, twenty-one (21) years of age or older, and who reside in one of nine (9) county jurisdiction that makes up the Greater San Francisco / Bay Area listening area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time, and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

- d. To claim a prize, the winner(s) must provide valid government-issued photo identification and provide their complete address, date of birth and phone number, and Social Security Number.
- e. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state, and local laws and regulations. By participating the entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

## 3. PRIZES

- a. One (1) prize will be awarded. The prize includes a prize package including 1-Night Stay for winner and one (1) guest on Friday, November 1, 2024 OR Saturday, November 2, 2024, dinner for two (2) at a Cache Creek restaurant, a round of golf on Saturday, November 2, 2024 at set time. Reservation limited

to standard rooms only, and not valid on blackout dates. Reservation date must be at least 60 days out (or as soon as possible) from when they are calling to make the reservation. Must be 21 years of age or older to book. Reservations require a credit card. Reservations subject to availability. No more than the stated number of prizes specified in these official rules will be awarded.

The approximate prize value is Five Hundred Dollars (\$500.00)

All prizes or prize certificates must be claimed at the office of the Station at the address below during regular business hours. The winner(s) will forfeit any prize(s) or prize certificate(s) not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed or shipped to the winner(s), it will be with the prior written consent of the winner(s) and therefore, the winner(s) assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize(s) or prize certificate(s).

- b. Other restrictions may apply.
- c. Winner will be required to provide his/her social security number and any other documentation and/or sign any documentation Station requires as determined in its sole discretion as a condition of accepting the Prize.
- d. All sales, prizes, and other taxes, gratuities, and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets that have been awarded in the event of show cancellations as a result of weather, promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper

execution of Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.

- e. In no event will more than the stated number of prizes be awarded.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. There will be one (1) prize winner selected from the qualifying online entries received at [www.KFOX.com](http://www.KFOX.com) at the conclusion of the Promotion as described above in Section 1 of these Official Rules.
- c. Odds of winning a qualifying prize depend upon the number and order of eligible entries received.
- d. Winners do not need to listen to the Station to win and do not need to be present to win. All prizes must be claimed within thirty (30) days of winning, as directed by the Station. - a. Any use of robotic, repetitive, automatic, programmed, or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Contest Administrator's computer or telephone system is the official time-keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering, or the administration of the Contest or the announcement of a prize; (ii) incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures; or (vi) any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to Entrant(s) and/or winner(s) (and winner's guest(s) if applicable) including any results thereof such as changes in services or location necessitated by same.
